The monograph will be available on the website of the European publisher "Izdevnieciba "Baltija Publishing" <u>at the link</u>.

The authors of the collective monograph's section receive <u>an electronic</u> <u>layout</u> of **the collective monograph and a certificate**.

#### **Key Dates:**

The submission of application forms and articles for publishing in the monograph: before September 29, 2023 (inclusively).

**Feedback on papers acceptance:** within 1–2 working days after papers receipt.

**E-mail distribution of the monograph's layout and the certificate:** after December 15, 2023.

## **Registration Procedure:**

To publish contributions in the collective monograph, authors should act as follows:

1. <u>fill in an application form</u> and send a manuscript to <u>soc@cuesc.org.ua</u> for peer-review **before September 29, 2023;** 

2. send a copy of the payment confirmation <u>following the manuscript's</u> <u>approval for publication</u>.

## Monograph's target subject-matter:

The monograph's concept is based on philosophical study of the paradigm of modernism and postmodernism within various dimensions of modern interdisciplinary philosophical discourse. Thus, the contribution will cover the following *issues:* 

- internal contradictions of modernism as a worldview, technology of thinking and social praxis;

- explanations of modernism and postmodernism in the light of Eastern and Western cultures;

- variations of modernism and modernization: Ukrainian society in the context of global processes;

- reactualization of modern and postmodern concepts of individual and society (historical and philosophical component);

- sociocultural globalization, transformations of scientific knowledge and the postmodern paradigm in contemporary philosophical thought;

- the discourse of postmodernism: particularities of narrative strategies;
- postmodern trends in philosophy and culture;
- worldview and sociocultural transformations of postmodernism.

Authors are invited to prepare materials meeting the above issues. The monograph's concept encourages the analytical activity of authors on studying modernism and postmodernism. According to its subject, research can deal with historical and philosophical aspects, in the panorama of time, and from the position of any branch of philosophical knowledge. In particular, the historical-philosophical insight will allow analyzing and making philosophical reflection the research subject at the theoretical level, and immersion in the socio-cultural situation – implementing the practical component of the research. The proposed logic will allow the authors to study the world in detail through the prism of modernism in its formation against the background of premodernity and postmodernity both in their history and in the actual present. These and other research aspects may highlight such axiological practical dimensions:

1) *methodological* will make the monograph a source of strengthening and deepening knowledge in specific branches of philosophical science;

2) *hermeneutic* may be implemented through immersion into classical and non-classical discourses and hence makes it possible to revise the ontological foundations of the language, the scope of the word, and the problems of hermeneutics, which are re-actualized toward the philosophical discourse of today;

3) *existential*, which is formed thanks to the disclosure of the complex and ambiguous nature of views on modernism and postmodernism from the standpoint of their social function in the philosophical and cultural traditions of the East and the West.

Please pay attention to the interdisciplinary nature of the research methodology, which should rely on various areas of scientific humanities: cultural studies, history, anthropology, linguistics, sociology, social studies of technology, etc. Therefore, authors can apply various research methods: comparative, structural, critical, analytical, interpretation methods, methods of empirical research, theoretical research, general logical methods of scientific research, as well as structural-functional, probabilistic methods, modeling, formalization, etc.

# **Prohibition to refer** to the aggressor state's scholarly papers:

We kindly note that the monograph's languages are Ukrainian, English, and Latvian. It is prohibited citing and including in the reference list russianlanguage contributions published in any country, incl. papers written in other languages but published in russia and belarus.

#### **Requirements for Articles' Execution:**

An article should be a holistic document of scientific content that involves the results of the author's original researchers.

The volume of the monograph subsection should be <u>at least 15–30 pages</u>. A4 paper format, line space -1,5; Times New Roman, 14 size; all margins -20 mm.

**3 persons** are a maximum number of authors.

Languages: Latvian, English and Ukrainian.

Monograph section name; author's surname and initials in the publication's language.

A paper should have the following structure: a short introduction (1-2 pages), 2–3 equally weighted sections and conclusion (1 page), summary: 7–10 sentences in the article's language (to indicate a range of problems and research results).

The article must have <u>per-page citations as well as References at the end</u>. Citations should be indicated with a number without brackets and dots using Microsoft Word references.

To improve the quality level of scientific citations in the scientometric database <u>Open Ukrainian Citation Index (OUCI)</u>, it is important to indicate **DOI** for every source which it has.

*Attention!* References are in a source language and executed taking into account the National Standard of Ukraine <u>DSTU 8302: 2015 "Information</u> and documentation. Bibliographic reference. General principles and rules of <u>composition"</u>.

Author's full name and information: scientific degree and rank, post, affiliation; address of employment place (in English regardless of the publication's language).

*Attention!* In case of submitting a non-English article, an author should additionally submit an English name of the section and its structural elements (subsections) (see a design sample).
