ORGANISATIONAL FEE:

The amount of the organisational fee for participants from Ukraine is **500 UAH**. For members of the Center for Ukrainian and European Scientific Cooperation, the registration fee is **400 UAH** (for information on how to become a member of the CUESC, please follow [the link](#)). Upon request, conference participants can additionally order a **printed collection** and a **certificate**. The cost of receiving printed materials, including shipping, is **500 UAH**, which must be paid in addition to the organisational fee. For citizens of other countries, the registration fee is \$15 (digital materials) and \$25 (printed materials).

All conference participants will be provided with a digital collection of conference abstracts and a certificate of participation. Conference participants will have the possibility to present a collection of materials and a certificate as a verification of participation in an international conference held in a country that is a member of the European Union.

** The certificate confirms participation in a scientific conference, such as a congress, symposium, or seminar, held in an EU country. It is in accordance with Clause 7.4 of Section 2 of the Procedure for Awarding Academic Titles to Researchers and Teaching Staff, approved by Order of the Ministry of Education and Science of Ukraine No. 13 of 14 January 2016.*

A collection of conference abstracts and a certificate will be sent to each participant by email after **13 October**.

Printed materials will be sent out after **31 October**.

Each scientific paper included in the conference abstracts will be assigned a **DOI**, which allows the authors to find their scientific work on [OUCL](#). The collection of abstracts will be assigned an ISBN by a European publisher. The digital version of the conference proceedings will be posted on the official website of [Baltija Publishing](#).

REQUIREMENTS FOR ABSTRACTS:

The title of the paper in Ukrainian and English is located in the centre (font - Times New Roman, size - 14, bold).

Below, at one interval, in the centre - the author's last name, first name, academic degree, academic title, position, full name of the institution where the author studies or works, city, country (in Ukrainian and English); font - Times New Roman, size - 14.

Single-spaced text of the abstract, which must meet the following requirements: A-4 format, margins: top, bottom, left, right - 2 cm, font - Times New Roman, size - 14, line spacing - 1.5.

The list of references (without repetitions) is made at the end of the text under the title "References:". In the text, references are indicated using square brackets with the relevant reference number and page number(s) separated by commas, for example: [7, p. 16].

Text volume: up to 5 pages with a list of references.

Please note that the **maximum number of co-authors** is 3.
