The authors are responsible for the content and accuracy of the theses.

REQUIREMENTS FOR SCIENTIFIC PAPERS

1. Total scope of a scientific paper – up to 5 pages using the MS Word processor (in doc or docx format); A4 paper size; page orientation: portrait, justified, all side indented: 20 mm; Font: Times New Roman (Font size – 14 pt.); Line spacing – 1.5.

The title of the file should be written in the same language as the scientific paper and consist of The Last Name and the initials of the conference participant, underscore and the word “scientific paper” (e.g., Ivanov I. I._ scientific paper).

2. The theme of the panel discussion should be outlined in scientific papers.

3. Information about the author of the publication (co-author) of the scientific paper should be center-aligned; (First name, Last name in Ukrainian (in the case of providing a scientific article in other languages: English or Russian), academic degree, academic rank, honorary title, position, place of employment, locality, country, ORCID ID, e-mail address).

4. Title should be in bold, center-aligned, capital letters, without abbreviations. In the case of writing papers in Ukrainian, the title must also be written in English.

5. Abstract is submitted in the amount of up to 300 characters (including spaces). Key words: in english up to 10 words.

6. In the main content, references are identified by square brackets indicating the ordinal number of the source on the list and with a comma – page number (pages), for example: [2] or [2, p. 291]. Another reference list is not allowed.

7. Reference list (without repetitions) is made out at the end of the text taking into account the National standard of Ukraine DSTU 8302: 2015, developed in 2015. «Information and documentation. Bibliographic reference. General provisions and rules of compilation».
